INTERIM ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Lebe Lanio for non-furnishing of information by the PIO-cum-Mission Director, (NABM)/ Member Secretary, (APBRDA), Itanagar, Chimpu (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 25.10.2023.

The appeal is heard today on 8th of November, 2024 as scheduled wherein the Appellant Shri Lebe Lamino is present but the PIO, Dr G Murtem, Mission Director, NABM/Member Secretary, Arunachal Pradesh Bamboo Research Development Agency (APBRDA), Chimpu is absent.

During the course of hearing the appellant furnished a copy of letter dated 19th November, 2023 addressed to him from the o/o of the PIO, Mission Director (SBM) advising the appellant to collect the information as sought for by him by depositing a sum of Rs. 216 Rupees (two hundred and sixteen) only being the cost of documents. The appellant also furnished the detailed statement of item wise replies from the PIO, on perusal of which the Commission finds that the replies to the queries at Sl. No. 3,5,6,7 and 8 are mentioned as 'NA'. Since the reply NA is vague reply, this Commission directs the PIO to furnish specific replies as to whether the informations are available or not with them. If the informations are not available then an affidavit declaring that the information are not available with them shall be sworn in and furnished to the appellant.

As regards, information in respect of remaining queries i.e Sl. No. 1, 2 and 4, the appellant had expressed his satisfaction on the information as received by him.

The PIO is directed to comply with the above direction within 3 (three) weeks from the date of receipt of this order and the appellant is also directed to intimate his satisfaction or otherwise to this Commission within one week from the receipt of the affidavit from the PIO whereafter the next date of hearing if required will be fixed.
