SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte, for non-furnishing of information by the PIO O/o the Executive Engineer (RWD) Likabali Division, Lower Siang District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005vide his application dated27.04.2023.

This appeal was heard for the 7th time on 6th December, 2024 wherein the representative of the PIO, o/o E.E (RWD), Likabali Division, Er. Shri P.C. Yadav, ASW had brought in the duly certified information sought for by the appellant which has been handed over to the appellant who has been directed to go through the same and report his satisfaction or otherwise within one week from 06.12.2024 so that next date of hearing, if required, can be fixed.

Now as directed, the appellant, vide his letter dt. 18.12.2024 addressed to the PIO, o/o E.E (RWD), Likabali Division, has intimated that documents furnished to him during the hearing are incomplete and not as per his RTI application.

This Commission on perusal of the said letter of the appellant, it is observed he has stated that information on most of the points have not been unfurnished.

This Commission, therefore, decide to hear the parties further.

Now, therefore, the PIO, O/o the EE (RWD), Likabali Division is hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC on the 29th January, 2025 (Wednesday) at 10.30 am to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense or online.

NOW THEREFORE, take notice that, in default of your appearance, on the day before mentioned, the matter will be heard and determined in your absence.
