## ORDER

The 2<sup>nd</sup> hearing held on 19<sup>th</sup> December, 2024 related to the APIC-No-693/2023. The Appellant Shri Riya Taram is present during the hearing. The PIO-cum-EE, RWD, Singchung Division, West Kameng District, Govt. of Arunachal Pradesh, is present during the hearing.

Heard the Appellant and the PIO:
