This is an appeal under Section 19(3) of RTI Act, 2005 received from **SmtiTongyang Mema Bengia, Lower Chimpu Itanagar, PO- Chimpu, PS- Itanagar, Arunachal Pradesh** for non-furnishing of information by **the PIO –cum- EE, RWD, Laying Yangte Division, Kurung Kumey District, Govt. of Arunachal Pradesh** as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

The hearing of this case for the 7th time was fixed today on 21st August, 2024. The PIO, Shri R W Zimik o/o the Executive Engineer, RWD, Laying Yangte Division, District Kurung Kumey, Arunachal Pradesh was present. The Appellant SmtiTongyang Mema Bengia was also present.

During the course of hearing the PIO furnished a copy of Govt. order dated 06-08-2024 by which he has been transferred from the present place of posting i.e Laying Yangte to Ziro. The PIO, while furnishing part of left out information clarified that as regards MB at Sl. No.- 6 of his letter the same has not been given by the JE concerned.

Since the PIO is already on transfer, the relieving officer of Shri R W Zimik is directed to attend the next hearing along with the left out documents.
