**Summon Notice.**

The 1st hearing held on 7<sup>th</sup> Nov ,2024 related to the **APIC No-1002/2023 (Appeal)**. The Appellant Shri Palen Laa present during the hearing and the PIO found absent without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides public duties, also has to attend Court hearing when an appeal is preferred against him as the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

Heard the Appellant.

The Appellant stated before the Commission that, he has not received the information(s) form the PIO office till date as sought in Form 'A' application of the Appellant.

After hearing the Appellant and going through the Form 'A' application of the Appellant, the Commission has viewed seriously, the absence of the PIO, in not attending the hearing

The Commission ordered;

- (i) To **summon** the PIO and directed him to furnish all the information(s) to the Appellant on or before next date of hearing. **Failing which Section 20(1) & (2) shall be initiated against the PIO as per the provisions of RTI Act, 2005.**
- (ii) Due to absence of the PIO, the Commission could not proceed the hearing of the appeal, and hence fixed a next date for hearing.
- (iii) Next date of hearing has been intimated to the Appellant. No formal notice required to be issued.

The Commission ordered;

**The next date of hearing is fixed on 19<sup>th</sup> December, 2024 at 10.30 AM (Morning)**
