**WHEREAS**, the Commission has seriously viewed on the PIO's reluctant attitude and directed to issue **summon** to the PIO to appear in person or through online mode in the next date of hearing and also directed to furnish all the information to the Appellant on or before the next date of hearing. **Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act, 2005.**
