ORDER

ii) The PIO-cum-Executive Engineer, UD & Housing, Capital Complex Division to provide the information(s) pertaining to Serial Nos. 2 and 4 to the Appellant on or before the next date of hearing, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005

iii) Notice be issued to the PIO-cum-EE, Capital Complex Division, Department of UD & Housing, Itanagar, to provide the information(s) and also to attend the next hearing on the date fixed.

The Commission hereby orders;

The next date of hearing be fixed on 14th October, 2025' at 2:30 PM (Evening)


