**ORDER**

The 1<sup>st</sup> hearing held on **12<sup>th</sup> December, 2024** related to the **APIC-No-249/2024**. The Appellant Shri Chow Puwan Chawpoo is present through online mode during the hearing. The PIO-cum-District Agriculture Officer (DAO), Namsai District, Govt. of Arunachal Pradesh is represented by Shri Lenjing Dai, ADO (HQ) Namsai –cum-APIO. Heard the Appellant and the APIO:

The Appellant informed the Commission that the information(s) provided by the PIO is incomplete and he has submitted fees amounting to information(s) for 23 pages but the PIO provided him only 18 pages of information(s).

The representative of the PIO stated that the information(s) sought in Serial No. 2 of the Form-A application of the Appellant is of personal information(s) which is exempted under Section 8 (g) of RTI, Act, 2005, and the information(s) sought in Serial No. 4 of the Form-A application has already been intimated to the Appellant by the First Appellate Authority on 23.07.2024, that the fund allotted is not allotted per hectare wise, but composite.

After hearing the Appellant and the APIO:

**The Commission ordered:**

- (i) The PIO to provide complete information(s) pertaining to the cumulative amount of fund/money that was paid to the beneficiaries.
- (ii) The next hearing notice need not be issued to the parties as they are personally present in the Court.
