**ORDER**

The 4<sup>th</sup> hearing held on **14<sup>th</sup> November, 2024** related to the **APIC No-140/2024**. The Appellant Shri Pem Dondup Thangkar and Shri Khandu Thongkar and the PIO-cum-Executive Engineer, PHE, Department, Dirang Sub-Division, West Kameng District, are present through online mode during the hearing before the Commission.
