WHEREAS, the 1<sup>st</sup> hearing held on 11<sup>th</sup> June, 2024 related to the APIC No-178/2024. The Appellants Shri Pate Mesi Lomdak and the PIO present during the hearing.

Heard both the parties.

The PIO stated before the Commission that the information(s) sought by the Appellant in his Form 'A' application are not under his jurisdiction as Appellant has wrongly filed the appeal under Superintending Engineer (SE) office but, however, O/o the SE written a letter to the concern competent Authority, Executive Engineer who are the main custodian of the documents.

Thereby, the Appellant sated before the Commission that he has received the information from the respective Divisions out of which Ziro Division furnished complete information, while other Divisions: Daporijo, Yazali, K/Daadi & Kurung Kumey furnished incomplete information to him and the Kamle Division is yet not furnish any information to him.

Accordingly, the Commission ordered/directed the concern competent Authority, Executive Engineer-cum-PIO's of respective Divisions Daporijo, Yazali, K/Daadi & Kurung Kumey to furnish complete information to the Appellant and Kamle Division also furnish all the informations to the Appellant as sought by him on or before next date of hearing. ***Failing which necessary action shall be initiated against the above mentioned Divisions concern PIO's as per the provisions of RTI Act, 2005.***

Next date of hearing has been intimated to both the parties. No formal notice required to be issued.
