<u>The5th hearing was held on 18thNovember, 2024</u> related to the APIC No-1012/2023 (Appeal). Both the parties, appellant ShriLenzingPertin, and PIO-cum-DFO, Pasighat Forest Division found absent without any intimation to the Commission.

On the 4th hearing date 28/10/2024 both the parties were also absent, however, the PIOcum-DFO, Pasighat Forest Division sent a letter addressed to the appellant Shri LenzingPertin and the copy also sent to the Commission which is in the case record. The PIO has stated that the information sought by the appellant are vague and confusing which is of voluminous and the PIO has intimated to the appellant through the letter that he can inspect, read, see and obtain ctc's of documents on 03/10/2024 during office hours. The appellant was also allowed to take photograph of the relevant documents and give list of documents wanted by him during or after the inspection.

Accordingly, the Commission has directed the appellant to inspect and get the documents from the PIO-cum-DFO, Pasighat Forest Division and intimate before the Commission on next date of hearing.

The appellant has also written letter to the PIO-cum-DFO, Pasighat Forest Division with a copy of letter is enclosed in the case record. He has stated that he could not inspect the said case record of the documents on 03/10/2024 because on the same date case hearing before the same Information Commission at Itanagar.

Considering the intimation made by both the party's the Commission has directed the PIO to give another date for inspection of the document by the appellant and also intimate to the Commission regarding new date of inspection. But till date no any information has been received from both the parties.

On this, the Commission directs both the parties to be present in person before the Commission in the next date of hearing and to intimate to the Commission whether the aforementioned inspection work has been done or not

The Commission adjourned the hearing and fixed next date of hearing on 09/12/2024 at 1030 hours.
