The Appellant stated that he has not yet received any information from the PIO and requested the Commission for summoning the PIO for next hearing.

After Hearing the Appellant and going through the Form A application of the Appellant, the Commission ordered;

- (i) The PIO to provide all the information(s) as sought in Form-A application of the Appellants on or before next date of hearing. ***Failing which necessary action shall be initiated against the PIO as per the provision of RTI, Act, 2005.***
- (ii) ***To summon the PIO to appear in person or through online mode in the next date of hearing.***
- (iii) Next date of hearing has been intimated to the Appellant. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 16th January' 2024 at 10:30 AM (Morning)
