ORDER

The 4th hearing held on 4th February 2025, related to the APIC No 191/2024. The Appellant Shri Dawa Tsering and APIO Shri Gollo Nera also present in person during the hearing.

Heard both the parties

The Appellant stated before the Commission that he has not received any of the information from the PIO till date. And no any correspondence received from the PIO's office despite repeated order passed by the Commission.

The APIO stated that the information as applied by the applicant are very voluminous and not specific and requested him to submit a fresh application with specific details of information(s) required. And The APIO further has requested the Commission that due to the frequent transfer of PIO-cum DFO, Dirang, documents could not be furnished to Appellant on time and furthermore, the APIO requested for giving them some more time to prepare the requested information(s).

After hearing both the parties and going through the form 'A' application of Appellant the Commission ordered;

- (i) The PIO to provide all the information(s) to the Appellant on or before the next date of hearing as sought in his form 'A' application of the Appellant, **failing which action under section 25(5) shall be initiated against the PIO as per the provision of RTI Act, 2005, and to attend the next date of hearing without fail.**
- (ii) The Appellant to collect all the information(s) from the PIO's office and convey the Commission in regard to complete or in-complete information received on or before the next date of hearing.
- (iii) The next date of hearing has been intimated to both the parties, No formal notice required to be issued.

The Commission ordered;

The next date of hearing is fixed on 8th April, 2025 at 1:30 PM (Afternoon)
