SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Lebe Lamnio r/o New Seppa P.O/ P.S- Seppa, East Kameng District, AP, for non-furnishing of information by the PIO O/o the Principal, Govt. Higher Secondary School, Pompoli, East Kameng District, Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

This appeal is heard for the 2nd time today on 05.07.2024 as scheduled wherein both the appellant Shri Lebe Lamnio and the PIO, Shri Obang Gao, Principal, Govt. Higher Secondary School, Pampoli, East Kameng District were present.

The appellant reiterated his demand for the information as sought in his application e.i the Date of Birth Certificate of Miss Yaping Rimo that was submitted at the time of admission in Class-IX in Govt. Higher Secondary School, Pampoli, East Kameng District. However, the PIO, as already replied earlier by him in letter dt.29.06.2023 addressed to the appellant, submitted that at the time of registration in Class-IX the date of birth of Miss Yaping Rimo was taken from the Transfer Certificate recorded as 10.09.2002 which is permissible as per CBSE guidelines and that at the time of admission in to Class-X the DoB 10.09.2002 was changed to 10.09.2010 which is also permissible.

The copies of School Leaving Certificate of Miss Yaping Rimo (Class-VIII) dt.26.06.2019 issued by Head Master, Govt. Secondary School, P-Sector, Itanagar and the Class-X pass certificate (CBSE) bearing the date of birth-10.09.2002 and 10.09.2006 respectively as furnished by the PIO have been seen.

The appellant, who was not satisfied with the submission of the PIO, insisted that if what the PIO submitted was the accepted procedure then the PIO be directed to furnish an affidavit to the effect that as per the guidelines of the CBSE, the date of birth recorded in the School Leaving Certificate /Transfer Certificate is also accepted while registering the students in the School. The Commission considered the request of the appellant and directed the PIO to furnish the affidavit within 2(two) weeks from today and in any case before the next date of hearing.

The next date of hearing is, therefore, fixed on 2 AUGUST,2024 FRIDAY AT02.00 PM

NOW THEREFORE, Shri O.Gao PIO O/o the Principal Govt.Higher Secondary School Pompoli East Kameng District, AP is hereby summoned to appear in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person or online on the above date and time without fail.
