## WARNING SUMMON

WHEREAS, in connection with the <u>APIC-No. 95/2025</u>, your personal appearance is required before the Commission on 21 October, 2025 at 02:30 PM. The  $2^{nd}$  hearing held on <u>10<sup>th</sup> July, 2025</u>'. The Appellant Shri Mamu sonu is present. The PIO-cum-EE, WRD, Bomdila Division, West Kameng District, Govt. of Arunachal Pradesh, found absent during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

## Heard the Appellant;

The Appellant stated that the PIO has not complied with the order of the Commission of the last hearing on 22.04.2025.

After hearing the Appellant and taking serious note of the absence of the PIO: The Commission hereby observes;

That the PIO was ordered to provide the information(s) pertaining to Serial Nos. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19,20, 21, 23, 24, 25, 26, 27, 28, and 29 to the Appellant by the PIO on 22<sup>nd</sup> April' 2025 to which the representative of the PIO Shri Likha Tasi (Assistant Engineer-cum-APIO) WRD, Bomdial Sub-Division had consented to comply with the order before the court of the Commission but today on the 2<sup>nd</sup> hearing the PIO is absent without reasons intimated to the Commission, and therefore, the Commission hereby orders as follows:

(i) The PIO to provide the above stated information(s) to the Appellant on or before the next date of hearing and to attend the next date of hearing without fail, failing which necessary action will be initiated against the PIO as provided in the RTI, Act. 2005.

- (ii) Warning summons to be issued the PIO to attend the next date of hearing in person or through online mode without fail.
- The Appellant to intimate of the information(s) received completely or not on or (iii) before the next date of hearing and to attend the hearing, failing which this instant appeal will be heard and determined ex-parte.
