## ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Ram Veo, C/o Advocate Nayam & Associate, Itafort Shopping Complex, Itanagar for non-furnishing of information by the SPIO-cum-EE(PHE & WS), Govt.A.P., Yingkiong Division, PO/PS Yingkiong, District Siang, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 28/02/2023 regarding Compensation of water supply or damage estimate / amount of Ditte-Dime-Migging Road Package-I to package-IV, for construction / Improvement of Road to NHDL Specification.
- 2). The 7<sup>th</sup> hearing was held on 1<sup>st</sup> October, 2024 as scheduled. The PIO-cum-EE(PHE & WS), Govt.A.P., Yingkiong Division, PO/PS Yingkiong, District Siang, Arunachal Pradesh is represented by Er. Atit Miyu, APIO-cum-AE (PHE & WS), Sub-Division, Yingkiong. The Appellant Shri Ram Veo is present.
- 3). The Appellant submitted that some information had been furnished but information for Sl.no. 1 to 9 have not been furnished as yet. The Appellant also submitted a letter No. NIL Dated 15/07/2024 stating the same. Further, the Appellant requested for site inspection of the work.
- 4). The APIO submitted that all the information available have been furnished to the Appellant, except for photographs and NIT. NIT was not done due to exigency issues. Also, the Application Form-A Dated 30/01/2024 does not have Sl.no. 3, 5, 8 & 9. So, what information, the Appellant is seeking is not understood.
- 5). The Commission after scrutiny of the file and records directed the PIO to furnish information as per the letter No. NIL Dated 15/07/2024 as submitted by the Appellant. In case information is not available the PIO should give justifiable reasons through AFFIDAVIT to the Appellant. Regarding inspection of site, the Commission shall give clarification in due course of time.

6). Both the parties are directed to appear before the Commission's court in person on the next date of hearing without fail. In case the PIO fails to appear, the Commission shall be compelled to invoke disciplinary action against the PIO under section 20(2) of the RTI Act, 2005. In case appellant remains absent the Commission shall dispose of the case without any further notice, on assumption that the Appellant is satisfied with the information furnished by the PIO.

The next date of hearing is fixed on 5<sup>th</sup> November, 2024 (Tuesday) at 1030hrs (Morning).
