Order

WHEREAS, the 2nd hearing held on **14th November' 2024** related to the **APIC No-207/2024**.
The Appellant Shri Riddam Kato and the PIO present during the hearing through on line mode.

Heard both parties:

The Appellant stated before the Commission that the PIO has not furnished any of the information(s) as sought by him in his Form 'A' application till date. The PIO stated that the Appellant has no right to be furnished with the GD Entry Documents.

After hearing both parties and going through the Form 'A' application , the Commission observed;

That the presumption of innocence is a legal principle that states that an accused is considered innocent until proven guilty. The Appellant is the complainant in two of the cases and is an accused in one of the case, for the details of which he has applied for the copies of the GD of the said cases. Every complainant and an Accused is a right to present evidences and witnesses to enable him to prove his case.

Therefore, the Commission order;

(i) The PIO to provide all the information(s) pertaining to Serial No. (i) (ii) & (iii) of the application of the Appellant be provided, on or before the next date of hearing. ***Failing which necessary action shall be initiated against the PIO as per the provisions of RTI, Act, 2025 and therefore***

(ii) Next date of hearing has been intimated to both the parties No formal notice required to be both the parties.

The Court ordered;

The next date of hearing be fixed on 21st Jan , 2025 at 1.30 PM (Afternoon)
