**Order**

**WHEREAS**, in connection with the **APIC-No. 174/2024**, the 3<sup>rd</sup> hearing held on **27<sup>th</sup> August, 2024** related to the **APIC No-174/2024**. The Appellant Shri Nabam Tai and the representative of PIO, the learned counsel Shri Lizar Bui present during the hearing.

Heard both the parties.

The learned counsel for the PIO stated before the Commission that the PIO has not received any application or request from the Applicant/ Appellant. So, asked for disposal of the appeal. On the other hand, the Appellant stated before the Commission that form 'A' application seeking for information(s) was sent through registered post through postal office on 31.01.2024.

After hearing both the parties, the Commission ordered;

- (i) The Appellant to provide the tracking evidence of his application, whether it was delivered to the PIO and the PIO has received it or not on or before next date of hearing. In case of the failure of the Appellant to provide evidence of his application for seeking information was delivered to the PIO, his appeal shall not be further heard and disposed.
- (ii) Next date of hearing has been intimated to the Appellant. No formal notice required to be issued.
