SUMMON

The 2nd hearing held on 11th February' 2025, related the APIC No. 1150/2024. The Appellant Shri Tania June and the PIO Chief Engineer Eastern Zone(EZ) Public Health Engineering Department (PHED) both are absent during the hearing without intimating to the Commission the reason for their inability to attend the hearing which is unbecoming on the part of the PIO, who has to be reminded that the PIO beside public duties, also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

The Commission viewed seriously on the absence of both the parties and Commission hereby orders;

- (i) **To summon** to the Appellant to be present in person or through online mode before the Commission in the next date of hearing, **failing which his appeal shall be decided Ex-parte.**
- (ii) **To issue summons** to the Chief Engineer (EZ) Public Health Engineering Department (PHE) to be present in person or through online mode before the Commission in the next date of hearing, **failing which necessary action shall be initiated against the CE, as per provisions of RTI Act, 2005.**
- (iii) **The PIO to provide all the information to the Appellant on or before next date of hearing. Failing which necessary action shall be initiated against the PIO as per the RTI Act, 2005.**

Due to absence of both the parties, the Commission could not proceed the hearing of the appeal.

The Commission fixed the next date of hearing on 17th April 2025, at 10.30 AM (Morning) and adjourned the hearing.
