**SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram for non-furnishing of information by the PIO, o/o the Executive Engineer RWD, Tezu Division, Lohit District, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide application dated 15.05.2023

This appeal is heard for the 4th time today on 10<sup>th</sup> January, 2025 as scheduled wherein the Appellant, Shri Riya Taram is absent and the APIO Smti Khyoda Meema AE, o/o the EE (RWD)Tezu Division, Lohit district, AP is present physically.

In the earlier order dated 27<sup>th</sup> November, 2024 the appellant was directed to return the documents which he received earlier so that the APIO could re-arrange the same on or before 10<sup>th</sup> Jan. 2025, the next date of hearing.

In today's hearing the APIO brought in the remaining documents like photographs and Utilization Certificate which, however, could not be handed over to the Appellant as he was absent.

The APIO expressed her dismay over the repeated absence of the appellant as the APIO has to come with documents from long distance wasting her valuable office time. The APIO also requested the Commission to dispose of the case.

The Commission, after hearing the APIO directs the appellant to be present personally in next hearing on 31<sup>st</sup> Jan. 2025 and if he remains absent again on that day with the compliance of earlier interim order dated 27/11/2024 the case will be disposed of as being not interested any more.

**The next date of hearing of this appeal is fixed on 31<sup>th</sup> January, 2025 at 02.00 pm.**

**NOW THEREFORE**, the parties are hereby directed to appear in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person on the above mention date and time without fail.
