ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Kirgo Sora, D-Sector, Naharlagun, PO-Naharlagun, District Papum Pare Arunachal Pradesh for non-furnishing of information by the SPIO-cum-EE(PWD), Basar Division, PO-Basar, Leparada District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 03/06/2023 regarding RCC Welcome Gate Basar, near Forest Check Gate, and RCC Basar Welcome Gate, Basar, near tri-junction of Bam-Akajan road and NyigamNyodu PMGSY ROAD.

The 4th hearing is held today on 30th April, 2024 as scheduled. Er. Dagli Kato, the SPIO-cum-EE(PWD), Basar Division, PO-Basar, Leparada District, Arunachal Pradesh is absent. The Appellant Sri Kirgo Sora is present. The PIO was present for other appeal hearing but left before this appeal case could be heard. The Appellant has submitted that he has been provided with good number of information but he has not been provided with **counter foil of cheque leaf, sanction order and work order.**

The Commission observes that the PIO was absent on the 3rd hearing held on 12th March, 2024 nor did he submit his reply to Show Cause Notice issued on 2nd hearing held on 28th November, 2023 there for he was penalized under section 20(1) of the RTI Act, 2005. Therefore, the PIO is hereby directed to deposit the penalty amount and bring copy of treasury challan being proof of the deposition of penal amount. He is also directed to bring **counter foil of cheque leaf, sanction order and work order** in the next date of hearing as sought for by the Appellant in the Form-A dated 03/06/2023. The court is adjourned for the next date of hearing.

Both the parties are directed to appear before the Commission's court in persons on the next date of hearing. In case the PIO fails to appear the Commission shall compelled to invoke recommendation of disciplinary action against the PIO under section 20(2) of the RTI Act, 2005. In case appellant remains absent the Commission shall dispose of the case without any further notice, presuming that the Appellant is no more interested in the information.

The next date of hearing is fixed on 2nd July, 2024 (Tuesday) at 1030 hrs.

Therefore, Er. Dagli Kato, the SPIO-cum-EE(PWD), Basar Division, PO-Basar, Leparada District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
