This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Pisa Tapam, Village-Sate, P.O-Sarli, P.S-Koloriang, Kurung Kumey District, Arunachal Pradesh for non-furnishing of information by the PIO -cum-BDO, CD Block Sarli & Polosang, P.O/P.S-Koloriang, Kurung Kumey District, Govt. of Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

During the last hearing held on 7th June, 2024 as scheduled. The Appellant was present but the PIO was absent. However, the PIO vide his application dated 06/06/2024 intimated his inability to attend today's hearing because another case is fixed on 08/06/2024 in the FAA, KurungKumey.
