**SUMMON.**

The 1<sup>st</sup> hearing held on 13<sup>th</sup> March 2025, related on APIC No.437/2024. The Appellant Shri Nabam Tai, found absent without intimating to the Commission the reason for their inability to attend the hearing but the representative of the PIO Shri Pura Pull (Forester) Silviculture Chimpu present during the hearing.

The representative of the PIO stated before the Commission that as per the hearing notice passed by the Commission, the PIO has given all information to Appellant as sought in his form 'A' application and receipt copy also obtained from the Appellant though the date was not mentioned in advertently. And going by the letter to Appellant exhibited by the representative of the PIO. It implies that Appellant has received the information on dated 3/02/2025 and may be, this is the reason not the Appellant has bothered to turn up in the hearing today.

**However the Commission observes;**

- (i) The Appellant need to be sent summon notice, after filing a appeal in the Commission the absence without intimation to the Commission gives the impression that the Appellant is not respecting the procedural laws of RTI Act, 2005. And therefore, he is not bothered to intimate to the Commission, the receipt of the information even after receiving the information from the PIO.

**The Commission hereby orders;**

- (i) To **summon** the Appellant to appear in person or through online mode before the Commission in the next date of hearing. **Failing which his appeal shall be decided Ex-parte.**
- (ii) The next date of hearing has been intimated to the representative of the PIO. No formal notice required to be issued.

**The next date of hearing be fixed on 3<sup>rd</sup> June 2025 at 10:30 AM**
