ORDER /SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram for non-furnishing of below mentioned information by the PIO, o/o E.E, (Electrical) Deomali Division, District Tirap, (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 18.11.2024.

A) Particulars of information: To furnish all the Relevant Information against the Name of Work/Scheme which enclosed with form ,A under BE. 2022-2023 for C/o 11kv line from Namsang to Longkhong to re-align Market-Longkhong feeder by avoiding dense forest cover and river crossing under 54-Namsang,Tirap District at Amount of Rs. 217.06 & C/o. Power Sub-division and Provision of Street Lights in various New colonies of Deomali Township in Tirap District. At Rs. 300.00. And also Give Reason for why EE/AE/JE Has taken Deduction of Amount from Sanction Amount/Estimated Cost (Rs) & Contractor Payment as Percentage i.e 21% GST/IT, 10% EE, 5% AE, 4%JE as per from Reliable sources Copy is Enclosed herewith form, A.

B) Details of information Required:

1. Furnish the (TS) Sanctioned order/DPR/Estimate/UC/LOC.
2. Give the Work order/Supply order copy/Name of work list.
3. Give the Name of Contractor/firm/enterprise with their Bank account number.
4. Furnish the First & final Bill copy of all the works . It must be prepared as per the amount which mentioned in the Sanctioned order/work order.
5. Give the Scheme detail sheet copy/Billing details sheet copy of all the works.
6. Give the Measurement Book(MB)details and cashbook Statement of works. it must be maintain as per the Sanction amount which mention in the Sanction Order/LOC/Work order/Supply order copy/Hand Receipt and Payees Name with its Signature.

7. Give the Xerox copy of Cheque Leaf/Cheque book counter foil/bill payment, counterfoil/demand, draft/banker cheque/ RTGS/PFMS Transaction against the above mentioned M/s. ATWA enterprise & M/s. Basang Traders . It should be paid as according to the sanction amount which mentioned in the Sanctioned order(TS)LOC/Work order.
8. Give the description of work/Supply work/Quantity/rate/per nos/amount _ . with cash memo/money receipt of every materials.
9. Give the Xerox copy of M/s. ATWA Enterprise of Trading License with their Bank account number. what is the NEXUS between Proprietor of M/s. ATWA Enterprise/M/s. Basang Traders and AE/JE/EE? Give the full Name of EE/AE/JE and Trading License owner/Proprietor of M/s. ATWA Enterprise & M/s Basang Traders.
10. Money deposited challan of Govt. Account against GST/Royalty by Above mention Enterprise/EE deomali Electrical account.
11. Give the list of Money Receipt/Payment List of all the Contractor with their Full Name and address /Contact Number.
12. Furnish the Cashbook Statement. It must be Prepared as per the Amount which mentioned in the Sanction Order/TS/LOC Copy.
13. Give the Hard copy of above mentioned enclosed copy herewith form, A which is regarding the List of Scheme under Deomali Sub-division 2022-23. Deomali Section.
14. Give the Name of Officers and Officials/Field officers with Designation who is/was the DDO Power or Executed the Above mentioned work/Fund.
15. Give the Reason. why EE/AE/JE Has taken amount from Sanction amount/Estimated Cost(Rs) & Contractor Payment as Percentage ie. 21% GST/IT, 10% EE, 5% AE, 4%JE against the above mention work ?
16. Why only amount of Rs. 191.00 (one crore ninety one lakhs) has been awarded to M/s. ATWA Enterprise for C/o 11kv line from Namsang to Longkhong to realign Market-Longkhong feeder by avoiding dense forest cover and river crossing under 54-Namsang, Tirap District out of Amount of Rs. 217.06. or why not full amount was not awarded? And also Give the Reason for not awarded full Sanctioned amount of Rs. 217.06. to Mentioned Firm and also Amount of Rs. 270.00 (Two crore Seventy Lakhs) has been Awarded to M/s. Basang Traders for C/o. Power Sub-division and Provision of Street Lights in various New colonies of Deomali Township in Tirap District out of Rs. 300.00. Why not awarded full amount?
17. Give the Certified coloring Photocopy of all works by concern PIO.
18. Furnish the description Coloring Photocopy of work site before starting of work/Starting of work and Ending of work site/Coloring photocopy of Geo-tag report.
19. Furnish the Billing details Sheet copy/Scheme details Sheet copy of every works.
20. Give the NIT Copy/Date of NIT Tender floated or Conducted/Total number bidders Apply of firms/Press Letter Paper Cutting/Photography/Videography of Tender Committees during the Tender called time/List of Tender Committee.
21. Give the tender agreement/Justified copy/Approval/Acceptance/EMD/Bank guarantee/MIS Report/UC Sign by CE/SE/EE,
22. Give the Security deposit of amount and account detail/Bill Voucher number, All the documents must be Furnish in CTC concern PIO, All the furnish documents must be in true certified copies by concern PIO.

C) Period from which information asked for ; 2022 to 2023

Brief facts emerging from the appeal :

Records emerging from the appeal disclose that the Appellant, Shri Riya Taram had requested the PIO for the aforementioned information/documents but failed to obtain the same which prompted him to appeal before the Chief Engineer (E), Govt. of A.P. (E/Z), Namsai, the First Appellate Authority (FAA) under Section 19 (1) of the RTI Act, 2005 vide Memo of Appeal Dated 19.12.2024. However, the appellant having failed yet again to obtain the information preferred 2nd appeal before this Commission under Section 19 (3) of the RTI Act. 2005 vide Memo of Appeal dated 17.02.2025.

This appeal is, accordingly, is listed today on 30th May, 2025 but none of the parties is present, though the appellant, Shri Riya Taram, vide his letter dt.30.05.2025, has informed that due to health issues he will not be able to attend the hearing.

The hearing of this appeal is, hence, adjourned to 4th July, 2025. If the appellant, fails to attend the hearing on that also, the appeal shall be closed as not pressed for hearing.
