ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tapak, Lekhi Village, Near Iconic Dealer, PO/PS Nirjuli, Papum Pare District, Arunachal Pradesh for non-furnishing of information by The PIO-cum-Dy State Project Director, Govt. of A.P., SAMAGRA SHIKSHA / ISSE ,RMSA, Itanagar, P/Pare District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 07/03/2022 regarding the details of appointment orders of PTI & PTI Grade-II, PTT, PET, PRT, TGT.
- 3). The 12th hearing was held on 30th July, 2024. The PIO –cum-DDSE, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh was represented by Shri Taba Guch, APIO-cum-BEO. The Appellant Shri Nabam Tapak was present. The APIO had submitted that AFFIDAVIT was furnished to the Appellant but the Appellant was not satisfied. The Appellant had submitted that information are incomplete and list had been submitted to the APIO for furnishing the same.
- 4). The PIO was directed to furnish all the available information under his control to the Appellant in legible form with proper authentication. In case if any information not available under his control, the PIO was directed to give justifiable reasons in AFFIDAVIT duly signed before the Notary Public or Judicial Magistrate.
- 5). The Commission to hear from both the parties fix next date of hearing.
- 6). **The next date of hearing is fixed on 17th December, 2024 (Tuesday) at 1030 hrs.**
- 7). Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO is found absent the Commission may initiate penal action as per provision under section 20(1) of the RTI Act-2005 and in case Appellant is found absent the case shall be disposed of without any further notice.
