SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received **Shri Nabam Tadap, Zoo Park Colony, P.O-RKM, P.S-Itanagar, Arunachal Pradesh** for non-furnishing of information by the **PIO-cum-EE, PHE & WS Itanagar, Govt. of Arunachal Pradesh** as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

During the last hearing of this case held on 05/06/2024 as scheduled. The Appellant was present and the APIO, Er Tad Logi, AE, PHE&WS Itanagar Division had represented the hearing on behalf of the PIO. Heard both the parties. The Appellant informed the Commission that he has not received the information pertaining to shifting of water pipe line at Right of Way (ROW) from Gohpur to NIT Jote. In response the representative of the PIO has informed that his office has not received such documents. Hence, a copy of the application form seeking information relating to shifting of water pipe line as stated above was provided to the representative of the PIO for furnishing the information to the Appellant. The representative of the PIO has assured the Commission to provide the same within one weeks time. On receiving the documents, the Appellant shall go through the same and inform his satisfaction/dissatisfaction on or before the next date of hearing of this case.
