An Appeal Case U/S 19(3) of RTI Act, 2005

Case No. APIC-201/2025.

(Summon to appear in person)

(Or.5, R.3 of CPC)

APPELLANT : Shri Tamchi Gungte, near KV-II School Itanagar.

RESPONDENT : The PIO, o/o the Block Development Officer, CD Block Bordumsa, Changlang District (A.P)

ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 52 (fifty two) point information on "The total list project sanctioned under Pradhan Mantri Jan Vikas Karyakaram (PMJVK), erstwhile MsDP Scheme, Ministry of Minority Affairs Govt. of India" by the PIO, o/o the Block Development Officer, CD Block, Bordumsa, District Changlang, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 11.11.2024.

This appeal is heard for the 2nd time today on 03.09.2025, the 1st time being on 11th June, 2025 wherein the appellant was present in person and the PIO, Shri Misa Gamlin, BDO attended the hearing through VC.

This Commission, after hearing the parties then and noticing that the information sought for by the appellant pertained to one funding head namely, 'Pradhan Mantri Jan Vikas Karyakaram (PMJVK)' (formerly, 'MsDP') and for one financial year i.e 2018-19, directed the PIO to furnish the requested documents/information to the appellant within one month from the date of receipt of order dt.13.06.2025 and it was made clear that if any of the requested documents was not being held by the o/o the PIO, then an affidavit to that effect with cogent reasons shall be furnished to the appellant as required under the appeal procedure rules.

The appellant had, however, complained vide his letter dt.11.07.2025 and subsequent letter dt. 31.07.2025 that the PIO failed to furnish the requested documents/information despite this Commission's order dt.13.06.2025 and as such pleaded for necessary action for non-compliance of the order and sought for hearing the appeal again.

This appeal is, therefore, listed for hearing again today on 03.09.2025 wherein the appellant is present in person but the PIO Shri P.D Mishra (recently transferred and posted vice Shri Misa Gamlin, the earlier BDO) attended the hearing through VC.

Heard the appellant who reiterated his written complaint submitted to this Commission earlier vide his letter dt. 31.07.2025. However, due to poor internet connectivity, the PIO could not be heard properly. Moreover, since the complaint of the appellant runs in to almost 12 pages (legal size paper), it would not have been possible to discuss and get clarification from the PIO on entire points contained in complaint through such a poor internet connectivity. Therefore, this Commission, with the consent of the PIO and the appellant, decides to adjourn the hearing of this appeal to 19th September wherein the PIO is directed to be present in person or through his APIO or any other authorized officer with well versed knowledge of this appeal.

This appeal is, thus, adjourned to 19th September, 2025.

NOW THEREFORE, you are hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC in person on the 19th Sept., 2025 (Friday) at 2 pm** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.


Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
