Order

WHEREAS, in the connection of APIC No.- 178/2024, the 2nd hearing held on 6th August, 2024 related to the APIC No-178/2024. The Appellant Shri Pate Mesi Lomdak found absent without intimating to the Commission the reason for his inability to attend the hearing but the PIO Shri Gyadi Taki present during the hearing.

Heard the PIO.

The PIO stated before the Commission that as per the order passed by this Court in the last hearing on dated 11/06/2024 and consequent upon the said order, the PIO has directed the concerned Executive Engineers of different Districts and Divisions to provide the information(s) but till now, some of the EE-cum-PIO's are not providing the information(s) to the Appellant.

After hearing the PIO, the Commission ordered ;

- (i) The concern Competent Authority, EE-cum-PIO's of respective Division's to provide the complete information(s) to the Appellant on or before the next date of hearing. ***Failing which necessary action shall be initiated against the Division's concern PIO's as per the provisions of RTI Act, 2005.***
- (ii) To **summon** to the Appellant to appear before the Commission in person or through online mode in the next date of hearing. ***Failing which his appeal shall be decided ex-parte.***
- (iii) Next date of hearing has been intimated to the PIO. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 5th September, 2024 at 10:30 AM (Morning)
