**ORDER**

**WHEREAS**, in connection with the **APIC-No. 223/2024**, your personal appearance is required before the Commission on **18<sup>th</sup> March, 2025 at 02:30 PM**. The **3<sup>rd</sup>** hearing held on **23<sup>th</sup> January, 2025**. The Appellant Shri Rania Nabam Hina absent PIO-cum- Executive Engineer (PHE &WS) Itanagar Division, both absent during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has as per the provisions of the RTI, Act 2005, which is a statutory duty binding upon the PIO.

The Commission viewed seriously on the absence of both the parties and the Commission ordered;

- (i) To **summon the PIO** to be present in person or through online mode before the Commission in the next date of hearing and to furnish all the information to the Appellant on or before next date of hearing. **Failing which necessary action shall be initiated against the PIO as per the RTI Act, 2005.**
- (ii) **To issue summon notice** to the Appellant to appear before the Commission in person or through online mode in the next date of hearing. **Failing which his appeal shall be decided ex-parte.**
- (iii) **Due to absence of both the parties, the Commission could not proceed the hearing of the instant appeal.**
- (iv) The Commission fixed the next date of hearing on **18<sup>th</sup> March 2:30PM(Afternoon)**
