**Details of information Required:**

1. Furnish the sanction letter of each and every fund allocation by the Central and State government for COVID-19 along with financial concurrence letter, administrative approval detail and authorization letter.
2. Furnish the name and details of file of the each and every COVID-19 fund.
3. Furnish the each and every correspondent letters, comments and file noting and observation of minister concern, secretary concern, DHS and other officer related to COVID-19, MLAs, Nodal Officer, TRIHMS-COVID-19 and DMOs for finalization of each and every proposal for management of COVID-19.
4. Furnish the details of each and every proposal submitted by the concern nodal officer COVID-19, TRIHMS and DMOs for allocation fund.
5. Furnish the component wise statement of expenditure.
6. Furnish the file details, noting comments and each and every correspondent's letters for purchasing and awarding of supply order from ICMR recommended medicine and other necessary items for Covid-19.
7. Furnish the file details observation details of work/supply order approved against various agencies, firm and manufacture for supply of approved medicine, equipments and other necessary items for Covid-19 along with the details of company, agencies and firms.
8. Furnish the payment made against purchase and procurement the all Covid-19 related items along with cheque details.
9. Furnish the receipt challan of all the supplies items for Covid-19 duly sign by the officer-in-charge for store and the any authorized officer.
10. Furnish the list of available Covid-19 related items such as medicine and injection equipment in the designated CCC.
11. Furnish the day and date of NIT publish in local dailies for each and every work and supply orders, relating to covid-19
12. Furnish if any criteria, guidelines, notification, cabinet notification framed/issued by Secretary for management of Covid-19 fund awarding of supply and purchasing of all requirement for Covid-19.

13. Furnish for the reason for delay of supply necessary items CCC.

14. Furnish the total expenditure and current balance amount.

15. Furnish a list of all vaccinated person.

Period: 2019 to till date.
