<u>ORDER</u>

This appeal was fixed for hearing for the 4th time today on 30/08/24.

In many of the hearings either the Appellant or the PIO or both were

During the last hearing held on 05-06-2024 wherein the Appellant was present and the representative of the PIO,Shri T Sangyu, JE(HQ) was also present the representative of the PIO assured to provide the information sought by the Appellant within one weeks time. On receiving the information, the Appellant was supposed to go through the same and inform his satisfaction/dissatisfaction on or before the next date of hearing which was fixed for 26th June, 2024.

Accordingly on 26th June, 2024 the APIO submitted that the information was kept ready for handing over to the appellant but the Appellant did not turn up to collect the information. As such the appellant was directed to collect the information from the PIO and intimate his acknowledgement of the receipt of the same on or before the next date of hearing fixed for 31st July, 2024.

This appeal is heard for the 4th time today on 30th August, 2024 as scheduled wherein the Appellant, Shri Kholie Modi was absent but the APIO, Shri Tangram Sangyu, o/o the EE, (RWD), Seppa Division, East Kameng District, AP was present through video conference. The APIO submitted that he has already handed over the documents to the Appellant during the last hearing on 31-07-2024.

Since the Appellants is not present in today's hearing, despite summon notice dated 02/08/24. This Commission is of the view that he is satisfied with the information he has received from the PIO and therefore, this Commission decides to dispose of and close the appeal once and for all which the Commission hereby does.
