## ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Enam Yangfo, Bazarline Seppa, PO/PS Seppa, East Kameng District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-DPDO, Govt. of A.P., O/O the District Panchayat Development Officer, Old DC Administrative Building Seppa, East Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/09/2024 regarding transferred / Distribution of Performance Grants (SoR) funds of Rs. 8, 48, 70, 000 of 2022-23 under XV FC in GPs & ZPs Accounts.
- 2). The 1<sup>st</sup> hearing was held on 29<sup>th</sup> April, 2025 as scheduled. The PIO-cum-DPDO, Govt. of A.P., O/O the District Panchayat Development Officer, Old DC Administrative Building Seppa, East Kameng District, Arunachal Pradesh was represented by Shri Achung Gyadi, APIO. The Appellant Adv. Enam Yangfo appeared before the court through Video Conferencing.
- 3). The Appellant submitted that the PIO has not furnished any information, with regard the sum of Rs. 8, 48, 70, 000 of 2022-23 under XV FC transferred in to Zilla Parishad & DPDO joint account on 31<sup>st</sup> October, 2023 vide PPA No. C102359433554 from the Directorate of Panchayati Raj, Itanagar.
- 4). The APIO submitted that they did not have any information as sought for by the Appellant in his application Form-A dated 25/02/2024, as no such fund had been received under 15<sup>th</sup> Finance Commission by their office. However, under SoR, fund had been received in the joint account of DPDO and Zila Parishad.
- 5). The Commission after hearing both the parties directed the Appellant to reframe the required information and seek for the information available, i.e. for SoR. The Commission also directed the PIO to furnish information as sought for by the Appellant.

- 6). The next date of hearing is fixed on 3rd June' 2025 (Tuesday) at 1100hrs.
- 7). Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO is found absent the Commission will initiate penal action under subsection (1) of Section (20) of the RTI Act, 2005. In case Appellant is found absent the case shall be disposed of without any further notice.
