SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tapak, Gyamar Hina for non-furnishing of information by the PIO O/o the Executive Engineer (RWD), Sagalee Division District Papum Pare, Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

The Appellant was present but the PIO was absent.

The Appellant, re-iterating his demand for information from the PIO, requested the Commission to direct the PIO, the E.E to attend the hearing failing which stern action should be initiated against him.

He also submitted that he had also met the S.E, the First Appellate Authority quite a few times but still he could not get the information from the PIO despite order dated 28/06/23 issued by the o/o the S.E.

The hearing of the appeal is, therefore, adjourned to 23/08/24, wherein the PIO shall be present.
