**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Chow Tasina Namchoom, Vill-Manfaiseng, PO-Nanam Shyam-1, PS-Namsai, District Namsai, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-BDO, Govt. of A.P., Bordumsa Division, Changlang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 05/06/2023 regarding Details of all the relevant information regarding execution of Mahatma Gandhi national rural Employment Guarantee Act (MGNREGA) at Bordumsa Circle.

The 3<sup>rd</sup> hearing is held today on 21<sup>st</sup> May, 2024 as scheduled. Shri Misa Gamlin, the PIO-cum-BDO, Govt. of A.P., Bordumsa Division, Changlang District, Arunachal Pradesh and the Appellant Shri Chow Tasina Namchoom are present. During the 2<sup>nd</sup> hearing the PIO was absent for that he was served with Show Cause Notice, as to why penal action should not be initiated against him for his willful absence. In his reply to Show Cause Notice, he has mentioned that he was engaged in the election duty of State Legislative Assembly and Parliamentary Election, 2024. Further, he has submitted that all the available information has been furnished to the Appellant. The Appellant has submitted that the information so furnished are okay but the PIO has not furnished information for Sl.no. b, j, k & l as sought for in the Form-A Dated 05/06/2023.

The Commission directs the PIO to furnish remaining information with authentication latest by 6<sup>th</sup> June, 2024, failing which Commission shall initiate penal action against the PIO. The Appellant is directed to contact the PIO to receive remaining information at the earliest possible. The court is adjourned for the next date of hearing

Both the parties are directed to appear before the Commission's court in persons on the next date of hearing. In case the SPIO fails to appear the Commission shall impose penal provision under section 20(1) of the RTI Act and if Appellant remains absent the Commission shall dispose of the case without any further notice, presuming that the Appellant has received the information and satisfied with the same.

**The next date of hearing is fixed on 30<sup>th</sup> July, 2024 (Tuesday) at 1030 hrs.**

**Therefore, Shri Misa Gamlin, the SPIO-cum-BDO, Govt. of A.P., Bordumsa Division, Changlang District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.**
