ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from **Shri Bamang Pacho, Forest Park, Near Main Powerhouse, House No. IMC-491, W-10, Itanagar, Arunachal Pradesh** for non-furnishing of information by the **PIO, o/o the BDO, Parsi Parlo, CD Block, Kurung Kumey District, Govt. of Arunachal Pradesh** as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

In the interim order dated 03/07/24 wherein both the parties were absent, this commission made the four BDOs of Parsi Parlo, Damin and Sarli, as the PIOs of respective offices for the purpose of consideration of the appeal no. 337, 338 and 339 respectively and accordingly, issued Summon notices to the aforesaid four BDOs to attend the hearing on 09/08/24. But, except the BDO, of Parsi Parlo namely, Shri Bengia Raja, the other 2 (two) BDOs did not attend the hearing.

The Appellant, Shri Bamang Pacho was present.

The PIO Shri Bengia Raja submitted that he had received the Appellant's application dated 03/02/24 for information from o/o the D.C Koloriang. The PIO had also brought in most of the information(s) requested by the Appellant except the Completion Certificate. The PIO, handing over the information(s) to the Appellan, explained point wise information to the Appellant.

As regards the completion certificate the PIO assured that the same will be provided to the Appellant within two weeks.

The Appellant is directed go through information(s) provided by the PIO and report his satisfactions or otherwise within two weeks time after which the date of hearing, if required, will be fixed and summon notice will be issued accordingly.
