## Summon Notice.

<u>The 8<sup>th</sup> hearing was held on 9<sup>th</sup> September, 2024</u> related to the APIC No-633/2023 (Appeal). Appellant present during the hearing, but PIOs found absent without any intimation to the Commission.

WHEREAS, as per the case record of 6<sup>th</sup> June, 2024 a letter forwarding of this appeal was already sent to the Superintendent Engineer (Coord), APPWD, Itanagar by the Principal Secretary (PWD) and 7<sup>th</sup> November 2023 Under Secretary (PWD), Govt. of Arunachal Pradesh has sent a forwarding letter to the SE (Coord)PWD, Itanagar for furnishing all the information sought by the appellant.

WHEREAS, as per order dated 17<sup>th</sup> June, 2024 the PIO stated that the information sought by the appellant has already been forwarded to the concerned Superintendent Engineer (Coord) (PWD) Itanagar, Superintendent Engineer (PWD), Sagalee and SE (PWD), Daporijo to furnish the information on RTI filed by the appellant and accordingly on the said hearing all the Superintendent Engineers were directed to furnish the information as sought by the appellant.

Whereas, again on 12<sup>th</sup> August, 2024 7<sup>th</sup> hearing, the PIO were directed to furnish all the information as sought by the appellant. A letter addressed to the Deputy Registrar, SIC has received from the SE (PWD), Sagalee stating that the information sought in Form 'A' application at Sl. No. 2 by the appellant has already been furnished to him. Sl. No. 1 information sought by the appellant is related to SE (Coord) PWD, Itanagar or SE, Daporijo Civil Circle PWD, Daporijo.

On considering submission made by the representative of the appellant, as per the case record, it is seen that the SE(Coord) PWD, Itanagar has already sent or forwarded to furnish the information as sought by the appellant, but even after 8<sup>th</sup> hearing SE (Coord) has not made any representation or any information to the appellant inspite of giving information.
