Summon Notice.

The PIO informed the Commission that after receipt of the Form-A application of the Appellant he has sent letter to the Appellant that the information(s) sought by him is ready, and therefore, to collect the information(s) after payment of requisite amount of Rs. 2367/- only but the Appellant did not turn-up to collect the information till date.
