Summon Notice.

The 1st hearing held on 7th November, 2024 related to the APIC No-782/2023. The Appellant Shri Nabam Sono is found absent but the PIO is present through online/video conferencing during the hearing before the Commission.

Heard the PIO:

The PIO informed the Commission that after receipt of the Form-A application of the Appellant he has sent letter to the Appellant that the information(s) sought by him is ready, and therefore, to collect the information(s) after payment of requisite amount of Rs. 2367/- only but the Appellant did not turn-up to collect the information till date.

After Hearing the APIO and going through the Form A application of the Appellant, the Commission ordered:

- (i) The Appellant collect the information from the office of the PIO and to inform the Commission about receipt of complete information as applied on or before the next date of hearing. Failing which necessary action shall be initiated against the Appellant as per the provision of RTI, Act, 2005.
- (ii) To issue summon notice to the Appellant to be present in the next date of hearing, failing which his appeal shall be decided ex-parte.
- (iii) Next date of hearing has been intimated to the PIO. No formal notice required to be issued.
