## **Summon Notice.**

The 7th hearing was held on 12th June, 2024 related to the APIC No-316/2023 (Appeal). The appellant present during the hearing. But the PIO found absent, however he intimated to the Commission through whattsup for inability to attend the hearing. He stated that on 11/6/2024 his vehicle was breakdown in between Raga to Puchigeko road when he has proceeded to Itanagar for attending the hearing on 12/6/2024.

As per order dated 04/12/2023 4th hearing, the Commission invoked under Sub-Section (1) of Section-20 of the RTI Act, 2005 and imposed Penalty amount of Rs. 25,000/- (Rupees twenty five thousand) only against the PIO for violation of Sub-Section-1 of Section-7 of the RTI Act, 2005. And the PIO was also directed to furnish the copy of the penalty deposit Treasury Challan to the Commission. Moreover, the PIO was again directed to compensate the appellant a sum of Rs. 5000/- (Rupees five thousand) only for the monetary losses which incurred during to & fro journey expenses etc. of appellant.

Penalty of Rs. 25,000/- (Rupees twenty five thousand) only has been deposited and a copy of Treasury Challan submitted in the Commission. Compensation amount of Rs. 5000/- (Rupees five thousand) only has also given to appellant. Receipt copy enclosed. Information sought to furnish to the appellant. Appellant is directed to intimate the Commission on or before next date of hearing regarding his satisfaction or dissatisfaction to the information provided. mder
