Summon Notice

WHEREAS, the 3rd hearing held on **26th November, 2024** related to the **APIC-No-189/2024**. The Appellant Shri Dawa Tsering is present in person. The PIO-cum-EE, PHED, Dirang Division, West Kameng District, Govt. of Arunachal Pradesh, is represented by the APIO, through online mode during the hearing.

Heard the Appellant and the APIO:

The APIO stated that he is ready to furnish all the information(s) sought by the Appellant, that the Appellant did not come to the office of the PIO to collect the information(s).

The Commission ordered:

- (ii) The Appellant to intimate the Commission whether he has received the complete information(s) on or before the next date of hearing.
- (iii) Notice need not be issued to both the parties as they have been already intimated in the Court.

The Commission ordered;

The next date of hearing be fixed on 4th February' 2025 at 1:30 PM (A/Noon)
