Summon Notice.

The **1st hearing** was held on 29th **January, 2025** related to the **APIC No-402/2024 (Appeal)**. Appellant, Shri Tagam Mibang present during the hearing but the PIO-cum-Under Secretary (Personnel) found absent without intimation to the Commission.

As per the case record the information sought by the appellant was provided in which the PIO has mentioned that out of 5 queries, information provided are of Sl. No. 2,4, & 5. Sl. No. query 1, the PIO has stated that letter was sent to Deputy Commission, Siang District for furnishing information for action from this end. However, no information was furnished to him.

Sl. No. query 3, promotion orders as Annexure-C is enclosed. However, PIO stated that the third party information sought cannot be issued as per the RTI Act.

The First Appellate Authority has given a reply to his appeal on dated 18/09/2024 asking him to deposit a sum of Rs. 112/- (Rupees one hundred twelve) only through Treasury Challan for providing information. The appellant has stated that he has already received 56 pages of information after depositing a sum of Rs. 112/- only as processing fee and he also stated that the information provided is not complete.

The appellant stated before the Court of Commission today that information provided to him is incomplete and not as per the queries made in the Form 'A' application. Appellant is directed to submit in writing regarding what information he

has not been provided as per the Form 'A' application which he has submitted before the PIO within 7(seven) days from the receipt of this order. It is also seen that the appeal was made before the First Appellate Authority-cum-Commissioner (Personnel) which was duly receipt by the OSD to Chief Secretary/Commissioner (Personnel)-cum-FAA on dated 15/12/2024.

The Commission fixed next date of hearing **17/03/2025 at 1030 hours.**
