The 6th hearing was held on 18th September, 2024 related to APIC NO-979/2023 (Appeal).

Both the parties appellant Shri Tania June and PIO- Cum- Commisioner, PWD, Civil Secretary Office, Itanagar found absent during the hearing without any information to the Commission.

As per the record of last hearing on 3rd July, 2024 one of the appellant name Shri Nikam Dabu has stated that the information as sought by him was provided by the PIO but some documents like PRC, ST Certificate, Class-X & Class-XII passed certificate has not been furnished. It is seen that the information sought by the appellant is third party's information which has barred under RTI Act under Section 18(j).

The appellant is directed to convince the court on next date of hearing that the information which seeking of large public interest. If it is not of the larger public interest, the documents sought will not be provided as per the exemption provision of RTI Act. The PIO is directed to be present in person before the Commission in next date of hearing and also directed to inform to the third party. If the appellant fails to appear in person before the Commission in the next date of hearing his appeal case shall be decided ex-parte and disposed off in his absence.

The Commission adjourned the hearing and fixed next date of hearing on **30/10/2024 at 2 PM.**
