The 10<sup>th</sup> hearing was held on 10<sup>th</sup> February, 2025 related to the APIC No-633/2023(Appeal). Appellant is represented by Learnt Advocate Ashmi Linggi and the PIO-cum-SE (PWD) Sagalee Circle is represented by EE (HQ), PWD, Sagalee Circle.

WHEREAS, it is seen from the case record that the information sought in the Form 'A' application, information sought in query No. 1 at Sl. No. 1,8 & 9 has been provided by SE(Coordination), PWD, Itanagar. The remaining appointment order for Sl. No. 2-7 and 10 has not been furnished till date as per the statement of appellant.

The query at Sl. No. 2 is also not been furnished to the appellant till date.

The representative of the PIO-cum-SE(PWD), Sagalee Circle has stated before the Commission today that query at Sl. No. 2 in the Form 'A' application has already been provided to the appellant regarding the appointment order WC Mazdoor against 2(two) vacant seat under SE(PWD), Sagalee Circle on compassionate ground. The Commission has gone through the case record and it is seen that the information sought was provided to the appellant on 05/08/2024 which is in the case record.

The PIO stated that the information for the query No. 1 is not available with them. It may be available with the SE (Coordination) PWD, Itanagar or SE (PWD), Daporijo Circle. Summon may be sent to SE (PWD) Daporijo and SE (Coordination), PWD, Itanagar.

No more summon letter be sent to the SE (PWD), Sagalee Circle.

So the Commission directs both the PIOs SE(Coordination), PWD, Itanagar and SE(PWD), Daporijo to be present in person before the Commission in the next date of hearing and furnish the information sought by the appellant on or before next date of hearing for query 1 of Serial No. 1-7 & 10.

The Commission fixed next date of hearing on 24/03/2025 at 1030 hours.
