**ORDER/SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Mamu Sono, Shri Deni Yangfo & Shri Rabo Lochung for non-furnishing of information by the PIO o/o the PD-cum-District Panchayat Development Officer (DPDO), Tawang District (A.P) as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 14.11.2023.

This appeal was heard on 13<sup>th</sup> of November, 2024 wherein the PIO, Shri Tenzin Jambey, the PD-cum-District Panchayat Development officer (DPDO), Tawang (AP) attended in person but the Appellants Shri Mamu Sono, Shri Tania Dongru and Shri Rabo Lochung did not turn up.

In the said hearing the PIO had brought in the documents for handing over to the appellants but since the appellants were absent, the documents could not be handed over to them. The Commission had, therefore, directed the appellants to collect the documents from the PIO and intimate their satisfaction or otherwise to this Commission on or before 22<sup>nd</sup> November, 2024, failing which, it was made clear, that the appeal shall be disposed of and closed as not being interested by them.

As directed, the appellants, it is observed, had collected the documents from the PIO and had gone through the same. One of the appellants, Shri Mamu Sono, vide his letter dt.25.11.2024 addressed to this Commission, has now intimated that he is not satisfied with the documents furnished by the PIO as the documents were not furnished point-wise, block-wise and year-wise regarding the 14<sup>th</sup> Finance Commission Grant/Scheme for the year, 2018-19 and 2019-20 as sought in his application in Form-A. He, therefore, pleaded this Commission for direction to the PIO to furnish the sought for information point-wise and with proper indexing as per his application.

This Commission also holds that the documents as sought for by an applicant ought to be furnished properly and to the full satisfaction of the applicant so as to comply with the mandate of the RTI regime and hence, this Commission directs the PIO to furnish the information sought for by the appellant in a tabulation form and in point-wise, block-wise and year-wise as sought for vide the appellants' application within 2(two) weeks from the date of issue of this order.

List this appeal for hearing on 20.12.2024 (Friday 2pm).
