SUMMON

WHEREAS, in connection with the **APIC-No. 190/2024**, your personal appearance is required before the Commission on **1st April, 2025 at 02:30 PM**. The **1st hearing** held on **28th January 2025**, related the **APIC No. 190/2024**. The Appellant Shri Pisa Tapam and PIO-cum-Executive Engineer, PHE & WS Dept.
