The Appellant Shri Mamu Sono, found absent during the hearing and PIO-cum-EE, WRD, Bomdila Div. - (ii) To summon the Appellant to appear in person or through online mode before the Commission in the next date of hearing. Failing which his appeal shall be decided ex-parte.

Due to absence of the both the parties, the Commission could not proceed the hearing of the appeal today.
