**SUMMON**

WHEREAS, in connection with the **APIC-No. 103/2025**, your personal appearance is required before the Commission on **29<sup>th</sup> July, 2025 at 02:30 PM**. - (i) To **summon** the PIO to appear in person or through online mode before the Commission in the next date of hearing. **Failing which necessary action shall be initiated against the PIO as per RTI Act 2005.**
- (ii) To **summon** the Appellant to appear in person or through online mode before the Commission in the next date of hearing. **Failing which his appeal shall be decided ex-parte.**

Due to absence of the both the parties, the Commission could not proceed the hearing of the appeal today.
