WHEREAS, in connection with the <u>APIC-No. 180/2024</u>, your personal appearance is required before the Commission on 06th August 2024 at 02:30 PM. The PIO present during the hearing but the Appellant Shri Dongru Tania found absent without intimating the reason to the Commission for his inability to attend the hearing.

WHEREAS, the PIO stated before the Commission that the information sought by the Appellant in his Form 'A' application is not specific. However, he has intimated to the Appellant on dated 28/02/2024 for depositing the requisite fees of Rs. 55,526/- (rupees fifty-five thousand five hundred twenty –six only) and collect the information (s) from his office but till date Appellant failed to turn up.

WHEREAS, after hearing the PIO, the Commission has seriously viewed on Appellant's reluctant attitude by not complying the order/direction of the PIO. Thereby, the Commission ordered / directed to *issue summon notice* to the Appellant to present in person or through online mode before the Commission in the next date of hearing and also ordered/directed to collect the information(s) from the PIO's office after depositing the requisite fees as mentioned above on or before next date of hearing. *Failing which his appeal shall be decided ex-parte as per the provisions of the RTI Act, 2005.*

Next date of hearing has been intimated to the PIO. No formal notice required to be issued.

The next date of hearing is fixed on 6th August, 2024 at 02:30 PM (Afternoon)
