**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri MiramDoso& 20 others, Damre Village, PO/PS Mariyang, Upper Siang District for non-furnishing of information by the SPIO-cum-EE (PHE & WS) Govt. of A.P., Yingkiong Division, Upper Siang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/01/2023 regarding all the documents of scheme / project names under PHE & WS Division Yingkiong in 40<sup>th</sup> Mariyang-Geku-Assembly constituency.

**The 6<sup>th</sup> hearing is held on 11<sup>th</sup> June, 2024 as scheduled.** Shri Rajen Tayeng, the PIO-cum-EE (PHE & WS) Govt. of A.P., Yingkiong Division, Upper Siang District, Arunachal Pradesh is absent. The Appellant is represented by Shri Jedi Pertin.

Though, the PIO has submitted reply to the Show Cause Notice vide Memo No. EEY/PHE/RTI-I/2024-25/94-96 Dated 15<sup>th</sup> May, 2024, the willful absence of the PIO is viewed seriously. Vide above memo, the PIO has informed that the Appellant has not specified the information till date so could not furnish information to him. The Commission tried to convince the Appellant to seek specific information of one work for one financial year but the Appellant could not spell out the name of the project or work. The Appellant sought time to ascertain the specific work/project.

The Commission giving reasonable opportunity directs the Appellant give specific name of one work / project within ten days from the date of issue of this order, i.e. by 19<sup>th</sup> June, 2024 the Appellant should submit the name of work / project to the PIO, so that the PIO can furnish him the information. The court is adjourned for the next date of hearing.

**The next date of hearing is fixed on 2<sup>nd</sup> July, 2024 (Tuesday) at 1030 hrs.**

Therefore, Shri Rajen Tayeng, the SPIO-cum-EE (PHE & WS) Govt. of A.P., Yingkiong Division, Upper Siang District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
