**SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from **Shri Bamang Pacho, Forest Park, Near Main Powerhouse, House No. IMC-491, W-10, Itanagar, Arunachal Pradesh** for non-furnishing of information by the **PIO—cum-BDO Damin, Sarli and Koloriang CD Blocks, Kurung Kumey District, Govt. of Arunachal Pradesh** as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

The 10<sup>th</sup> hearing of the case was fixed today on 03/07/24. But both the parties are absent.

In the 9<sup>th</sup> hearing of this appeal on 12/06/24 wherein the Appellant was present but the PIO was absent, the Appellant, Shri Bamang Pacho informed that the information(s) sought by him from the PIO o/o the PD, DRDA, Koloriang are not available with him but with the respective BDO of Damin, Sarli, Parsi Parlo and Koloriang, Blocks.

The PIO o/o the PD, DRDA, Koloriang, had also informed earlier that the information sought are not under his custody.

The Commission, therefore, deemed it appropriate to make the BDOs of Damin, Sarli, Parsi Parlo and Koloriang as the respondent PIOs in this appeal and issued summon to them for hearing on 03/07/24.

It is, however, noted that the summons issued through the WT message to the aforesaid BDOs were wrongly issued to PD, DRDA, Koloriang for which the aforesaid BDOs could not attend the hearing on 03/07/24.

The next hearing is, therefore, fixed on 09/08/24.

**NOW THEREFORE**, PIO, O/o the BDO Damin CD Blocks, Koloriang, Kurung Kumey District, Govt. of Arunachal Pradesh is hereby summoned to appear in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person or online on the above scheduled date and time without.
